

ROXY'S "ROXY CHICKEN JAM" SWEEPSTAKES- OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER. VOID WHERE PROHIBITED BY LAW.

1. **Who Can Enter:** Any legal resident of Canada, excluding Quebec, or the 50 states of the U.S. or the District of Columbia, 13 years of age or older is eligible to participate in ROXY'S "Roxy Chicken Jam" Sweepstakes (the "Sweepstakes"). Employees, officers, principals or directors of Quiksilver, Inc., and its subsidiaries, affiliates, advertising and promotional agencies (collectively, the "Sponsor"), and their households or immediate family members and/or those living in the same household with any of them, are not eligible to participate.

Entries must be submitted between 12:01 a.m. Pacific Time on April 7, 2011 ("Sweepstakes Open Time") and 11:59 p.m. Pacific Time on April 12, 2011 ("Sweepstakes Close Time"). All Twitter entries that are incomplete or late will be disqualified. Entries will be deemed to have been submitted by the registered account holder of the Twitter user name that submitted the entry. Entrants using more than one (1) Twitter account to enter the Sweepstakes will be disqualified. **Limit one (1) entry per person. Multiple entries using the same Twitter account will not be accepted.**

3. **Sweepstakes Dates:** The Sweepstakes will begin exactly at the Sweepstakes Open Time and end exactly at the Sweepstakes Close Time. Any entries that are incomplete or late will be disqualified.

4. **Prizes:** One (1) winner will be chosen at random (the "Winner"). The Winner will receive one (1) Roxy Chicken Jam t-shirt, two (2) Trouble Andrew CDs, and one (1) SpiritHoods hood. The prize has an approximate retail value of \$160. All prizes are "AS IS" without any warranty of any kind, express or implied. No substitution, exchange or transfer of prizes will be made or is permitted.

The prize will be awarded to the person submitting the entry, provided they certify and establish to Sponsor's satisfaction that they are the owner of the entry and further provided that they have complied with these Official Rules and have signed all necessary forms and releases as determined by Sponsor, in its sole discretion.

5. **Prize Drawings:** The Winner will be selected in a random drawing conducted by the Sponsor based on eligible entries properly submitted via Twitter between the Sweepstakes Open Time and the Sweepstakes Close Time. The prize drawing for the Sweepstakes will be held at the Sponsor's offices located at 15202 Graham Street, Huntington Beach, California 92649 on or around April 13, 2011. The Winner will be announced on Roxy's Twitter page, and notified via direct message on Twitter.

6. **Odds of Winning:** Each entrant's odds of winning are dependent on the aggregate number of eligible entries properly submitted between the Sweepstakes Open Time and the Sweepstakes

Close Time. No purchase of any kind is necessary in order to enter the Sweepstakes or win any prize, and chances of winning are not enhanced by making any purchases.

7. Winner Notification: The Winner will be notified by direct message on Twitter within 48 hours after determination of the Winner. The Winner will be required to respond to the direct message on Twitter to acknowledge receipt of Sponsor's notification and awarding of prizes. If no response is received by Sponsor from Winner within seven (7) calendar days of delivery of the prize notification from Sponsor, the prize will be awarded to a replacement winner to be determined by the Sponsor in the Sponsor's sole and absolute discretion.
